Executive Session: Vice President Braam motioned and Treasurer English seconded the motion to enter Executive Session at 5:28pm. Secretary Ciuffini motioned and Vice President Braam seconded the motion to leave Executive Session at 5:53pm. Vice President Braam motioned and Treasurer English seconded the motion to name Ashley Hopper as Library Director, effective May 1, 2014. Vice President Braam also motioned and Treasurer English seconded the motion to allow Director Pet to change insurance plan, with cost not to exceed current insurance cost. Both motions passed unanimously.
