**DIRECTOR'S REPORT:** Director Hopper reported that the library's membership into IMRF began December 1, 2019. **ByLaws:** Discussed recent updates to By-laws as discussed at recent By-laws Committee meeting. Changes include update to reconsideration of materials policy, computer user agreement, donation policy, and added social media policy. Also updated policy for disruptive behavior to include cannabis use and sexual harassment policy to include elected officials (as required by law and under advisement of attorney). Treasurer English motioned and Trustee Ralston seconded the motion to approve changes to By-Laws. Motion passed unanimously with a roll call vote.

**Serving Our Public:** President Gill reviewed and discussed Chapters 11 (System and ILLINET Membership Responsibilities) and 11 (Safety).

## UNFINISHED BUSINESS: None NEW BUSINESS:

**School Cards** – Director discussed the possibility of issuing library cards to all students enrolled in Manhattan and Elwood schools. Also discussed how to handle situations where student has existing library card with fees and whether students would incur fees on overdue materials. Next steps are to continue to work out various details as well as begin to work with attorney to draft intergovernmental agreement between the library and schools.

**Ordinance 20-1** – Trustee Ralson motioned and Treasurer English seconded the motion to adopt Ordinance 20-1, which amends Sexual Harassment Ordinance 18-1 to include elected officials in the policy. Motion passed unanimously with a roll call vote.
